

The Explosive Options Bracket Challenge Official Rules

NO PURCHASE NECESSARY TO ENTER PLAY, OR WIN. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.

The Explosive Options Bracket Challenge (the “Challenge”) is sponsored by Aztec Capital LLC (“Sponsor”). By participating in the Challenge you agree to be bound by applicable laws and these official rules.

The Challenge is not sponsored by, endorsed, or associated with CBS SPORTS. By entering you understand that you are providing your Challenge-related information to the Sponsor and all inquiries related to the Challenge should be directed to the Sponsor.

Eligibility:

The challenge is open to all legal United States residents who are 18 years of age or older at the time of entry and throughout the Challenge period. Void where taxed, restricted, or prohibited by law. Affiliates of Sponsor, their households and immediate family members are not eligible to win. The Challenge is subject to all federal, state, and local laws and regulations.

Challenge Entry & Timing:

The Challenge follows the 2019 NCAA Men's Basketball Tournament (the “Tournament”) schedule. The Tournament is split into five (5) rounds and a championship game. The Tournament begins March 19 and ends with the championship game April 8.

Entries must be received by **5 PM PST on March 20, 2019** for participants to take part in the Challenge. Upon acceptance of the rules and entrance, participant will be provided entry to the Explosive Options Bracket Challenge on CBS Sports where participant may complete their Tournament bracket.

Basketball teams will be finalized for Tournament play by the NCAA on March 17, 2019. Challenge Participants may complete their brackets anytime between March 17 and tip off of the first game on March 21. If a participant does not complete their bracket by tip off of the first game, they will be ineligible to compete.

Winner Selection & Notification

Scores and rankings will be determined by CBS Sports' standard scoring values.

Participants will accrue points for correct bracket entries on the following scale:

- Round 1: 1 Point for each correct entry
- Round 2: 2 Points for each correct entry
- Round 3: 4 Points for each correct entry
- Round 4: 8 Points for each correct entry
- Round 5: 16 Points for each correct entry
- Championship Game: 36 Points for the winning entry
- Tiebreaker: The total score of the Championship game

The winners will be selected based on their Challenge standing at the close of the Tournament. All winners will be notified with 24 hours of the close of the Challenge period via email, using the email address specified at the time of entry.

How to Enter:

Participants must enter through the contest application on the Explosive Options website by providing their full name, a valid email address and agreeing to official rules.

After successful entry participants will be provided a link via email to join the Challenge Group on CBS SPORTS's Fantasy application. If Participants do not have an existing account, they must create an account on CBSSPORTS.com and agree to their terms and conditions in order to participate in the Group. If participants do not join the Group on CBSsports.com within 48 hours after receipt of the invitation, they may forfeit their Challenge entry and lose their place in the Group.

Challenge Participation:

Participants must complete their Tournament bracket within the Group CBSSPORTS.com by the tip off of the first game on March 21, 2019. Brackets may not be edited once Tournament play begins.

Winners will be selected based on total points accrued. Participants may complete one (1) bracket only.

Odds of Winning:

The odds of winning depend on the number of eligible entries received. The Challenge has a maximum participation of four hundred (400) players.

Online Registration:
